1. We buy kitchen equipment out of general funds.

3. We give memorials for our members in the following manner: \$10.00 for spouse or child, \$5.00 for parent, grandchild or sibling. Memorial money goes to Trinity Gifts & Memorials Fund.
4. We pay \$50.00 to the division that serves the Senior Reception, but with certain stipulations..
5. **We do not allow any equipment to be taken from the kitchen.**
6. We furnish money for confirmation stoles.
7. We pay .54 cents per mile for WELCA delegates to conventions and workshops. We also pay for meals for officers who attend workshops.
8. We furnish new members with The Lutheran Woman Today at no charge for one year.
9. We furnish towels for baptism.
10. We allow \$100.00 for sewing supplies.
11. We donate \$110.00 to the LMH Auxiliary to be paid in January
12. WELCA pays transportation costs for shipping quilts.
13. We pay for holiday gifts for our Trinity members in nursing homes and in the Lutheran Manor.
14. We request donations of \$50.00 or more to the WELCA for a division working in the kitchen for an anniversary.
15. We will pay up to \$50.00 per year, plus mileage for guest speakers.
16. Lace tablecloths may be used only in church by church members. There will be a small fee for laundering.
17. We pay \$100.00 for entertainment and cake for LMH birthday parties.

Working Division Responsibilities

Working divisions have the following responsibilities delegated by the WELCA executive board:

- A. Take care of own expenses, except for the graduate reception
- B. Serve food and work in the kitchen for assigned functions
- C. Make coffee and other beverages which are furnished by WELCA
- D. Contact your division for needed food, money, and workers
- E. Make sure tables are set up and taken down.

There are flower arrangements in the southwest storeroom for table decorations.

When a division is assigned a funeral, the co-chairs will be notified by the WELCA president. WELCA furnishes cakes and beverages and the family provides everything else. The co-chairs need to call members for cakes and workers. **Contact funeral helpers (p. 4) if more help is needed.**

Helpful notes: To serve 150 people you will need 11 cakes (9x13 cut into 15 pieces). To serve 200 people you will need 14 cakes.

Liners and tablecloths: Liners are in tubs in the southeast store-room and in the cupboard in the back entry. There are banquet type tablecloths and white tablecloths for the round tables in the west storeroom in the balcony. **Lace tablecloths may be used only in the church by members for church functions. There will be a small charge for laundering.**

A punch bowl is located in the top cupboard of the broom closet in the kitchen.
