You are asked to bring the current copy of "The Lutheran Women Today" magazine and a Bible. There will be no assigned Bible study leader.

Trinity WELCA Policies

- 1. We buy kitchen equipment out of general funds.
- 2. We make quarterly payments to WELCA, 50% of the regular business meeting offerings and Circle meetings.
- 3. We give memorials for our members in the following manner: \$10.00 for spouse or child, \$5.00 for parent, grandchild or sibling. Memorial money goes to Trinity Gifts & Memorials Fund.
- 4. We pay \$50.00 to the division that serves the Senior Reception, but with certain stipulations..
- 5. We do not allow any equipment to be taken from the kitchen.
- 6. We furnish money for confirmation stoles.
- 7. We pay .54 cents per mile for WELCA delegates to conventions and workshops. We also pay for meals for officers who attend workshops.
- 8. We furnish new members with <u>The Lutheran Woman Today</u> at no charge for one year.
- 9. We furnish towels for baptism.
- 10. We allow \$100.00 for sewing supplies.
- 11. We donate \$110.00 to the LMH Auxiliary to be paid in January
- 12. WELCA pays transportation costs for shipping quilts.
- 13. We pay for holiday gifts for our Trinity members in nursing Homes, in the Lutheran Manor and anyone over 90 years.
- 14. We request donations of \$50.00 or more to the WELCA for a division working in the kitchen for an anniversary.
- 15. We will pay up to \$50.00 per year, plus mileage for guest speakers.
- 16. Lace tablecloths may be used only in church by church mem bers. There will be a small fee for laundering.
- 17. We pay \$100.00 for entertainment and cake for LMH birthday parties.
